## **GST LIABILITY WAIVER & ASSUMPTION OF RISK**

This document affects your legal rights.

I understand and have had explained to me that Gracie Survival Tactics is based on the martial art known as “Gracie Jiu-Jitsu” and is taught using all precautions to avoid any injuries. However, it may entail some risk of accident or injury and that this may be serious or even mortal as a consequence of the practice of the before mentioned Gracie Survival Tactics or Gracie Jiu-Jitsu.

The practice of Gracie Jiu-Jitsu presents a risk of skin infections, MRSA, transmittable diseases, bacteria(s) and viruses, including, but not limited to, COVID-19. I shall not attend Gracie Jiu-Jitsu classes if I am diagnosed with COVID-19 or if I am in close contact with someone diagnosed with COVID-19. Further, if I am displaying symptoms of COVID-19, or if I am in close contact with someone who is displaying symptoms of COVID-19, I shall not attend Gracie Jiu-Jitsu classes. Symptoms of COVID-19 can range from mild illness to pneumonia, including fever, respiratory symptoms such as coughing, sore throat and/or shortness of breath, and other symptoms such as a runny nose, headache, muscle or joint pains, nausea, diarrhea, vomiting, loss of sense of smell, altered sense of taste, loss of appetite and fatigue. If I am displaying these symptoms when in attendance at Gracie Jiu-Jitsu classes I acknowledge that I may be asked to leave.

I understand and have had explained to me that, along with the possibility of personal injury, injury to property is also possible, such as, but not limited to possible loss of wages and the ability to earn such wages.

With full knowledge of the aforementioned dangers, both to my person and to my property (current and future), and after having these dangers fully explained to myself, I hereby certify and declare that I will release and forever hold free and discharge from any liability Gracie Global LLC, d.b.a. Gracie University and each of their agents, stockholders, directors, officers, employees and representatives of and from all claims, demands, rights and causes of action of any nature whatsoever which may have or which may hereafter accrue to me, arising from and by reason of any and all bodily or personal injury, damage to property or other loss and any consequence thereof, whether known or unknown, seen or unforeseen, resulting from my participation in Gracie Survival Tactics or Gracie Jiu-Jitsu, their persons and entities mentioned above.

Further, knowing and understanding these risks, nevertheless I hereby agree to voluntarily assume these risks and to release and hold harmless all the persons or entities mentioned above whom might otherwise be liable to me for damages. It is further understood that this waiver, release and assumption of risk is forever binding on my heirs and assigns. I also understand and acknowledge that I have and will maintain appropriate medical insurance during classes/training.

I am also aware that for purposes of safety, security and quality control there may be surveillance cameras mounted throughout the training facility. Furthermore, because of the popularity of Gracie University, I understand and acknowledge that often times filming, video or photographs may be taken of me during classes/training. I hereby grant Gracie Global LLC, d.b.a. Gracie University the unlimited use of my likeness in any format (video, photo, or other) for promotional, advertisement or commercial use in perpetuity, and I forfeit any form of payment for such rights. It is further understood that I will not film or photograph any classes/training without prior permission from Gracie University.

Upon successful completion of the Gracie Survival Tactics course, I understand that my authorization to teach the course material is strictly trained limited to the personnel at my agency/organization. Under no circumstances am I authorized to teach the course to outside agencies/organizations without prior written approval from Gracie University.

I understand it is my responsibility to ensure that any techniques I learn effectively adhere to my agency’s Use of Force policy before I teach them to my colleagues. I agree never to bring any of the following into the training area:

- Lethal weapons
- Live ammunition
- Chemical munitions
- Pepper spray
- Edge weapons
- Hazardous items

My signature on this document is evidence that I know and understand and have had this document explained to me, that I fully understand the dangers that are inherent in this martial art and that I voluntarily certify that I will not hold Gracie Global LLC, d.b.a. Gracie University, Rener Gracie, Ryron Gracie, the Gracie family, their agents and/or instructors, responsible for any injury whether as a result of training or not. In addition, I agree to follow the safety protocols presented to all students of Gracie Survival Tactics at the time of registration and during the training.

## GST STUDENT CODE OF CONDUCT
